RHANA Meeting Minutes

January 5, 2009

- Meeting called to order by Sheryl at 7:05
- Diana gave the Treasurer's Report
- A motion was made and seconded to accept the Treasurer's Report and the minutes from Nov. 3, 2008
- Sheryl reported on the Quiet Zone at UPRR River Bend Blvd.; she stated \$450,000 was paid for a quiet zone we don't have; she asked that if you hear a train horn to call the numbers printed in the last RHANA News; do not call the train yard
- Audience member concerns:
 - getting the neighborhood cleaned up; it was stated that our Code Enforcement Officer sleeps in the park
 - trash cans left out
- Sheryl reported that the neighborhood street signs will be paid for next week
- It was stated that advertisements are needed in the RHANA News; these ads raise money for the association; call Diana if you or someone you know wants to place an ad
- Kevin Strawser from Chesapeake gave a report on the Ridglea South Well:
 - A new well was started in December-it will be drilled south to RCC to keep obligations with contracts
 - There will be 8 wells; 4 of these wells will be drilled to the north but there is no timeline
 - Kevin shares this area with Mercedes Bauldwin
- Officer Rick Demore was not able to make the meeting; there was no report by the officer who came in his place but he did answer questions from the audience members
- A report was given by Sandy:
 - Train horns: the amount of train horns being blown is under 10%; there have only been 28 reports out of 300 trains passing through; if you hear a train horn please report it with the following information: time the horn sounded, the direction of the train and the engine number; the engineers have been told about the quiet zone; the city is installing cameras at River Bend Blvd
 - Code violations in the neighborhood are being checked on; some issues in code are in the court process-it takes time
